- Dawn Perlmutter, 18 W. College Avenue. Spoke about the noise and crowds at the Taproom and the asked why the code enforcement officer and the police did not stop the event for violations.

Police service statistics for April 2021: There were 444 calls for service, 54 traffic citations, 1 non-traffic citations, 6 traffic accidents, and 3 arrests (1 for DUI.)

Drug takeback on 4/24. 33.5 pounds of unused drugs were collected by Yardley Police and over 9000 pounds in the county, illustrating how important this program is and the quantity of dangerous drugs in people's homes.
