A. Yardley Inn Improvements – Conditional Accessory Use of a Restaurant

The whole of 27-618 was reviewed and compared against the applicant's exhibits and attestations. The relevant portions of 27-1315 were also reviewed. Mr. McGuigan presented evidence supporting Yardley Inn's current and proposed compliance with all ordinance and conditional use requirements. The planning commission sees no need for variance nor waivers.

It is noteworthy that the proposal provides for 1,350 sf of seating area under the tent, and approximately 675 sf of seating area immediately southwest of the tent. This provides for 76 additional seats and about twelve parking spaces are taken out of service. By variance previously granted and with the updated off-site parking agreements shown, the applicant project remains in compliance for parking.

CD expressed concern about safety in the parking lot at creek edge drop off. Mr. McGuigan agreed that the applicant will address this concern.

Mr. Hodge motioned to recommend approval of the Conditional Accessory Use of a Restaurant in accordance with 27-618 Outdoor Dining Accessory to Restaurant, which is seconded by Mr. Bushar. A vote was held and the motion passed 5-0.

# B. 2024 Yardley Borough Comprehensive Plan Update

A discussion was held regarding the long-term project of updating the 2014 Comprehensive Plan which ideally is revisited and renewed every ten years. It is acknowledged that professional help will be needed, and that there are grant opportunities to assist with the plan update. Ms. Dawson offered to do some preliminary research on grant funding opportunities to engage a consultant to assist with this project.
