Yardley Borough Council Meeting July 20, 2021

 The meeting, held in Council Chambers, was called to order at 7:30pm.

Mr. Bria announces the agenda has been changed to remove the vote regarding the Zoning Hearing Board Appeal and moved to an executive session with no vote.

V. PUBLIC COMMENT

- Commander Ted Smith, 114 Yardley Commons, addressed Council regarding the flagpole that is in front of Borough Hall. Mr. Smith gave a brief history on the flagpole. In keeping with the original intent of the flagpole, he asks to pass a resolution to permit only the American flag to be flown on this flagpole.
- Albert Celini, 18 Van Horn asks Council for a status of potential fines for ML7 environmental remediations violations. Ms. Colletti reports they could move forward with citations if ML7 did not provide submissions which ML7 did provide.
- Paul Brzozowski, 106 S. Main St, addressed Council regarding the variance for the Taproom stating the applicant must have a hardship. Mr. Brzozowski asks Council to appeal the decision stating a wood smoker will release thousands of pounds of carbon dioxide.
- Scott Burney, 37 S. Main St, addressed Council regarding the gas fired smoker issue. He states over a 12-hour period, 2-3 sticks provide the smoke and is less than what a firepit would have in 2 hrs.
- Susan Taylor, 35 Lookover Ln, addressed Council about the Taproom and states Council should be focusing on the larger issues of proper zoning practices. Mr. Harding thanks Ms. Taylor for her accolades regarding the canal.

- Dawn Perlmutter, 18 W. College addressed Council with a handout and would like handout from last meeting removed from the minutes and replaced with the current handout. Ms. Perlmutter discusses emails about the Taproom and accessory use and her Right to Know. She also addresses the Tannery Taproom listening sessions and who is enforcing the seating capacity.

- Mayor Harding, 121 S. Main, addressed Council about American Legion and who they can contact about the flagpole.
